##### B. Schedule of Public Bidding

The public bidding shall be conducted on an "as is, where is" and on a **BY ITEM** basis by the NEDA Property Disposal Committee (NPDC) on **June 13, 2014, 12:00 p.m.** at the **3rd Flr. Conference Rm. (Infrastructure Staff Area), NEDA sa Pasig**

##### C. Qualification of Bidders

Individuals, including NEDA employees, partnerships and/or corporations are qualified to participate in the bidding, subject to the submission of qualification documents, as may be required by the NPDC.

Duly authorized representative/s, if any, shall submit a certification issued by the President/General Manager/Governing Board/Owner of the firm, as may be applicable, authorizing him/her to speak for and submit bids in behalf of the latter.

##### D. Floor Price

Floor price of the properties, shall be determined/set in accordance with accounting and auditing rules and regulations.



2. The Bid Bond shall be returned to the concerned bidder/s after the winning bidder has completed the pick-up/hauling of the properties.

#### K. Failure of Bidding

Failure of bidding shall be declared in the following instances:

1. If compliant bidders failed to meet the floor price (bids are below the floor price).
2. If prospective bidders are declared ineligible, no bids are received, all bids fail to comply with the bid requirements, and, subject to the conditions in Sections G.3 and H.4, the winning bidder refuses to accept the award or the winning bidder fails to make the payment on time.

The NPDC will conduct a rebidding.

In case of a **second failure of bidding**, the NPDC will post the ItBid and will conduct negotiated sale with the bidder who submitted the highest and responsive bid in response to said ItBid.
