SECRETARY'S MESSAGE

The challenge of development planning is one of balance. It is a matter of meeting what we call the “change challenge” while continuing the “sustainability challenge.” And while sweeping reforms and stable policies are both essential in maintaining growth and pursuing progress, there are times when we feel as if we are being pulled in opposite directions – do we shake things up or do we continue doing what works? Fortunately, the National Economic and Development Authority (NEDA) is guided by the vision of a prosperous, predominantly middle-class country by 2040.

AmBisyon Natin 2040 – the long-term vision of the Filipino people – calls for inclusive development, where no Filipino is left behind. NEDA, guided by the vision, was steadfast in performing its mandate as the country’s development plan and policy coordinator, public investment programmer and evaluator, development performance monitor and evaluator, and policy and technical adviser.

In 2017, the Philippine economy remained strong and stable, managing to grow by 6.7 percent. This solid performance kept our country’s standing as one of the fastest-growing economies in Asia, after China (6.9%) and Vietnam (6.8%). This consistently strong economic growth can be attributed to economic reforms initiated by the government, paving the way for a stable economy where growth is sustainable and inclusive.

The **Philippine Development Plan (PDP) 2017-2022**, the government’s comprehensive plan for change, was approved by the NEDA Board in 2017 and launched in the same year. This PDP is special, as it is the first of four Plans geared towards the achievement of ***AmBisyon***.

Aside from the PDP, NEDA through its Regional Offices (NROs) also finalized the Regional Development Plans (RDPs), to serve as guides for regional development planning. Meanwhile, to achieve the goals outlined in the PDP, the Results Matrices (RMs) have also been formulated and finalized last year.

To bring development to the regions, the Agency led the formulation of the National Spatial Strategy. Other Plans in support of infrastructure development were also prepared last year such as the Manila Bay Sustainable Development Master Plan, Philippine Transportation System Master Plan, and the Philippine Water Supply and Sanitation Master Plan.



With the groundwork for reforms we already initiated in 2017, I am confident that, through our concerted actions, we will be able to build a solid path to inclusive and sustained economic growth.

To help rebuild Marawi, including the residents displaced by the siege, the NEDA Central Office (NCO) and NROs provided technical assistance on the Bangon Marawi Comprehensive Rehabilitation and Recovery Program including the Marawi Siege Post-Conflict Needs Assessment. The Agency, as vice-chair for Disaster Rehabilitation and Recovery for Regional Disaster Risk Reduction and Management (DRRM)

Councils, also provided technical assistance in the formulation of various Rehabilitation and Recovery Plans (RRP) for typhoons, earthquakes, and other natural calamities.

As public investment programmer and evaluator, NEDA appraised programs and projects to ensure that these are aligned with the country's development plans. The Agency, through the NEDA Board chaired by the President, approved 20 projects worth ₱985,389.86 billion, most of these in the regions, to aggressively pursue rural and regional development.

As development performance monitor and evaluator, NEDA provided monitoring and evaluation services that are useful in measuring the development impact of government programs and projects in the country. The NROs prepared the quarterly Regional Project Monitoring and Evaluation System (RPMES) Reports and conducted field visits to monitor and validate the status of the implementation of the programs and projects reported in the RPMES. Joint supervision missions and project visits were also conducted by NEDA and major development partners to assess the performance of official development assistance (ODA) projects in the country.

As policy and technical support coordinator and adviser, the Agency prepared, reviewed,

and submitted a total of 1,030 policy papers for the President, Senate, House of Representatives, and other external stakeholders at the national and regional levels. These proposed legislations and policies include studies on the impact of the TRAIN Law, *Build, Build, Build* program, Jeepney Modernization Program, Rightsizing and Strengthening Bill, among others.

Apart from these, NEDA continued its regular work, updating the Office of the President and working with Senate and House leaders on policy matters. Together with its six attached agencies, NEDA provided complementary services and outputs such as tariff reports, socioeconomic indicators, and research data to sharpen government's development strategies.

To improve human resource and organizational capabilities, NEDA also conducted and participated in training seminars and embarked on ISO certification process towards ensuring consistent high-quality outputs and services. Some of the NROs have already received the ISO certification.

I would like to extend my gratitude to the competent and dedicated officials and staffs of NEDA who tirelessly worked to accomplish the strategies and priorities set out to be undertaken by the Agency in 2017. I am proud of their contributions to our noteworthy accomplishments.

I hope this Report serves as testimony to NEDA's steadfast commitment to attain an equitably progressive Philippines where growth is inclusive. And we hope every Filipino and other sectors of society including our development partners will be one with us in our effort to translate this growth into a *matatag, maginhawa at panatag na buhay para sa lahat*.

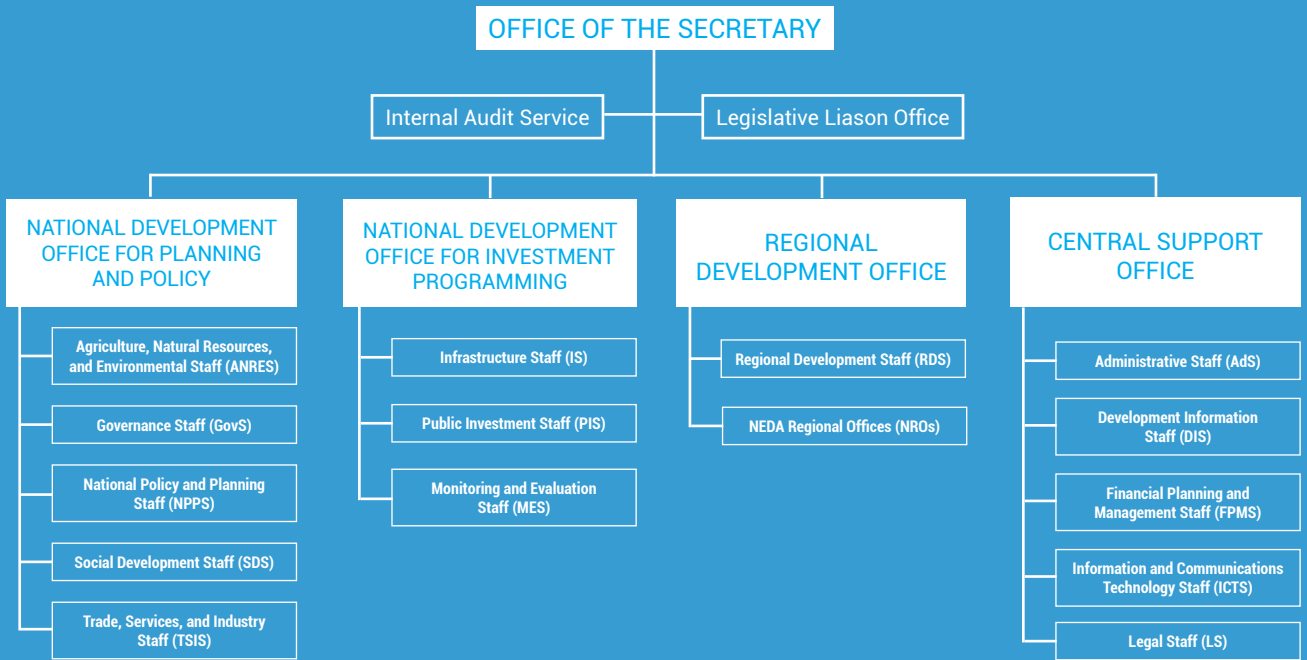

DEVELOPMENT PLANNING AND POLICY COORDINATION

NEDA steered processes for socioeconomic and physical planning across agencies



Philippine Development Plan (PDP) 2017-2022

NEDA led the crafting of the PDP 2017-2022, the country's economic blueprint, which is designed to be the first of four PDPs to be geared towards the attainment of the vision of a *matatag, maginhawa, at panatag na buhay para sa lahat*, as outlined in *AmBisyon Natin 2040*. The PDP is also anchored on the 0-10 Point Socioeconomic Agenda of the Duterte administration and factors in the country's international commitment to Sustainable Development Goals (SDGs).

The Plan, which was shaped through collaboration with various stakeholders, was presented to and approved by the NEDA Board on February 20, 2017 and was launched on June 2, 2017. Consequently, the

President issued Executive Order (EO) No. 27, directing all government agencies and instrumentalities, including local government units (LGUs), to implement, adopt, and disseminate the PDP and the Public Investment Program (PIP) 2017-2022 (*Refer to page 9 for details on the PIP*).

The PDP 2017-2022 aims to lay down a solid foundation for more inclusive growth, a high-trust and resilient society, and a globally-competitive knowledge economy. The strategies to achieve these targets by 2022 are under the three major pillars of "*malasakit*" or enhancing the social fabric, which focuses on governance and cultural awareness; "*pagbabago*" or inequality-reducing transformation, which focuses on equalizing opportunities and social protection;

and "*patuloy na pag-unlad*" or increasing growth potential, which pays attention to the country's population structure, and gives important to science, technology and innovation. Cross-cutting strategies, such as macroeconomic stability, infrastructure and regional development, ensuring peace and order, and safeguarding ecological integrity, are likewise included to make all other strategies work.

Regional Development Plans (RDPs) 2017-2022

The PDP is complemented by Regional Development Plans (RDPs), which are handled by NEDA's Regional Offices (NROs). Aligned with the PDP goals, the RDPs set out the regional development priorities and strategies and were formulated in consultation




The first full year of the current administration saw NEDA play an active and critical role in instituting changes and pushing for the sustainability and achievement of the Filipino people's vision of a "*matatag, maginhawa, at panatag na buhay*" or *AmBisyon Natin 2040*. With the government-wide call to partner for change, NEDA rose to the challenge by providing more proactive and efficient services through (a) development planning and policy coordination, (b) public investment programming and evaluation, (c) development performance monitoring and evaluation, and (d) policy and technical advice and support.

with stakeholders – local government units (LGUs), regional line agencies (RLAs), civil society organizations (CSOs), the private sector, and the academe, among others. In the same year, NEDA through the NROs, also formulated the Regional Development Research Agenda to guide policy and decision makers, research and non-government institutions, and individual researchers in identifying priority research areas supportive of the regional development agenda.

Shepherding the crafting of broad policy directions to address challenges and to contribute to the attainment of *AmBisyon Natin 2040*

National Spatial Strategy

NEDA spearheaded the formulation of a National Spatial Strategy (NSS) to address socioeconomic inequalities by decongesting the National Capital Region (NCR) and spreading growth to key urban centers across the country. Specifically, the NSS components are regional agglomeration, connectivity, and reduction of vulnerability. As part of the PDP 2017-2022, it seeks to link economically-lagging regions with regions that are more progressive, taking into account population trends, economic activities, and services in defining the country's desired spatial structure.

Reports on Socioeconomic Indicators

To monitor economic trends and developments, NEDA regularly submits to the President memoranda and technical reports on the latest results of the survey/estimate of social and macroeconomic indicators released by the Philippine Statistics Authority (PSA). Through these reports, NEDA informs the President of the current macroeconomic situation, provides outlooks, and recommends appropriate policy actions. These include quarterly reports on (a) National Income Accounts; (b) Labor Force Survey; and monthly reports on (c) Consumer Price Index; (d) Merchandise Trade (Imports and Exports); and (e) Manufacturing Sector Performance based on the results of the Monthly Integrated Survey of Selected Industries (MISSI). Memoranda and reports on urgent and emerging issues were also provided as NEDA deemed necessary.

NEDA also produced macroeconomic impact analyses of domestic and international developments, minimum wage, Tax Reform for Acceleration and Inclusion (TRAIN), and Build, Build, Build, among others, to guide policy and decision makers.

Food Security Committee on Rice (FSC-Rice) Assessment on Rice Supply and Demand

As chair of the FSC-Rice, NEDA conducted quarterly meetings to assess the country's rice supply and demand. The recommendations of the Committee were then submitted to the National Food Authority (NFA) Council to guide its Council members' decision on the need to supplement domestic production with imports.

Development of Natural Capital Accounting (NCA) Roadmap

NEDA facilitated the development of the roadmap in planning, programming, and budgeting to institutionalize the NCA in the Philippines. With the Department of Environment and Natural Resources (DENR) as partner, as well as other agencies, the institutionalization of the NCA in the country will consider the use and application of the following frameworks: (a) Systems of National Accounts; (b) Systems of Environmental-Economic Accounting (SEEA) Central Framework; and (c) SEEA Experimental-Accounting. Among others, such frameworks will guide the regular collection and utilization of environment and natural resources (ENR) statistics to address the growing demand for ENR indicators in the Philippines.

Individual Action Plan (IAP) for the Renewed APEC Agenda for Structural Reform (RAASR)

NEDA facilitated the progress reporting of the country's IAP under the RAASR. Adopted in 2015, the RAASR aims to advance structural reforms in support of changing government policies and regulations that make economic transactions of institutions more efficient. Specifically, the IAP covers improving the efficiency of the logistics sector including broadband access and usage; developing and institutionalizing quality regulatory management system; making the legislative and regulatory framework more conducive to the promotion of market competition; improving access of micro, small, and medium enterprises to financial services; and promoting skills development opportunities.

Development of mechanisms for monitoring and reporting the country's progress in meeting the Sustainable

Development Goals and targets

NEDA conducted workshops to establish necessary frameworks for generating and disseminating statistics and indicators needed by various stakeholders and data users in policy formulation, development planning, and decision making. These include workshops on SDG integration in the Regional Statistical Development Program 2017-2022 in the regions and National/Regional Strategic Priorities and Sustainable Development Goals Alignment.

Meanwhile, the PSA coordinated some of the SDG assessment workshops to assess the applicability of SDG indicators and generate additional support for each SDG goal to address data gaps.

Formulation of Rehabilitation and Recovery Programs (RRPs)

NEDA drafted the RRP Guide which serves as reference of the Disaster Rehabilitation and Recovery Management Councils (DRRMCs) at the national, regional, and local levels in the formulation of RRP. As vice-chair of Regional DRRMCs, the NROs provided technical assistance in the formulation of RRP and spearheaded the preparation of macroeconomic analyses used in post-disaster needs assessment for past disasters (e.g., typhoons Niña, Nona, Karen, Pablo and Lawin, Batangas and Leyte earthquakes, El Niño, etc.)



Needs Assessment (PCNA) national writeshop. The writeshop is meant to prepare the various agencies and organization in gathering inputs for the Post-Disaster Rehabilitation and Recovery Guide. It took into consideration the challenges encountered in the implementation of rehabilitation programs, including lessons and insights learned from past disasters.

To identify common elements in the RRP that can be adopted by all regions, NEDA Bicol conducted a workshop on the formulation of the Rehabilitation and Recovery Framework and discussed activities for the integration of the RRP for typhoon Niña in CALABARZON, MIMAROPA, and Bicol.

Monitoring and Rehabilitation and Recovery Projects for Typhoon Yolanda-Affected Areas

In line with NEDA's coordination, monitoring, and evaluation functions under Memorandum Order (MO) No. 79 s. 2015, NEDA prepared periodic progress reports (e.g., Progress Report of Yolanda Comprehensive Rehabilitation and Recovery Program or YCRRP) on the status of the implementation of Yolanda rehabilitation and recovery programs and projects. It also intensified its project monitoring on Yolanda rehabilitation programs and projects particularly in the resettlement sites in Northern Cebu. It assisted in the selection and endorsement of beneficiaries of 48 housing units in Bantayan. With the issuance of AO No. 5 in August 2017, the monitoring of the YCRRP was transferred to the Office of the Cabinet Secretary as head of the Inter-agency Task Force for Yolanda.

Bangon Marawi Comprehensive Rehabilitation and Recovery Program (BMCRRP)

NEDA was designated as the lead agency through Task Force Bangon Marawi Memorandum Circular No. 4, s. 2017 in the formulation of the BMCRRP including the preparation of a preliminary report in coordination with concerned government agencies, Autonomous Region in Muslim Mindanao, and LGUS affected by the armed conflict. The Task Force Bangon Marawi Planning Support Group was also convened to discuss the plan preparation process and expected deliverables from concerned agencies.

With technical support from the World Bank (WB) and the Asian Development Bank (ADB), NEDA designed lectures, discussions, and other technical inputs with the Office of Civil Defense for the Post-Conflict

Preparation and formulation of a National Competition Policy (NCP)

NEDA, with the Philippine Competition Commission (PCC), commenced the preparation and formulation of the NCP, as required under the Philippine Competition Act (Republic Act or RA 10667). The NCP will provide the guiding framework on market competition for both the private and the public sectors.

With the NCP in place, a clear policy framework will be implemented in various branches of the government for every Filipino to enjoy the benefits of increased market competition such as lower prices, higher quality, and wider choices of goods and services.



Formulation of master plans/roadmaps on sustainable development of Manila Bay; Philippine transportation system/networks; and Philippine water supply, sanitation, and sewerage

NEDA led the formulation of the Manila Bay Sustainable Development Master Plan which aims to provide a comprehensive and institutional framework for the sustainable development of the entire Manila Bay area. The masterplan shall guide decision makers in approving programs, activities, and projects that will not only develop but will also address issues (e.g., pollution, storm surge) within the bay area.

In view of the important role of the transportation sector in facilitating the movement of people, goods, and services in support of the performance of other productive sectors and in the provision of equitable access to basic services, NEDA spearheaded the formulation of the Philippine Transportation System Master Plan (PTSMP) which shall guide the rational development of an intermodal transport network in the country through coordinated planning and operation of projects and programs as an integrated network of intermodal sub-systems.

NEDA also led the formulation of the Philippine Water Supply Sanitation and Sewerage Master Plan (PWSSMP) which aims to set the direction in attaining the targets of the country's water supply and sanitation, through the development of strategies and policy reforms, and the identification of priority programs and projects for implementation.

Regional consultations were held nationwide on the formulation of both the PTSMP and PWSSMP, with the NROs providing technical inputs on the development plans of LGUs.

PUBLIC INVESTMENT PROGRAMMING AND EVALUATION

NEDA facilitated the country's investment programming and directed/aligned resources for investment toward priority areas

Public Investment Program (PIP) 2017-2022

To achieve the goals and outcomes highlighted in the PDP 2017-2022, NEDA formulated and updated the PIP 2017-2022 by regularly providing status reports on the Strategic Core Investment Programs and Projects (CIPs), including the updated list of NEDA Board-approved projects.

The PIP contains the list of priority programs and projects responsive to the PDP and RMs, to be implemented by the national government agencies, government-owned and controlled corporations (GOCCs), government financial institutions (GFIs), and other national government offices within the medium term. It links the Plan with the budget by ensuring that programs and projects contribute to the achievement of the PDP goals. These programs and projects may be financed using national government funds, including internal cash generated by GOCCs, in partnership with the private sector or through official development assistance (ODA).

Regional Development Investment Program (RDIP) 2017-2022

The NROs formulated the RDIPs 2017-2022 to guide regional line agencies, state universities and colleges (SUCs), and LGUs in coming up with priority programs and projects to improve the lives of the people in the regions, as enunciated under the RDPs. The programs and projects include the regions' indicative financial requirements for five years. The annual portion of the RDIP or the Annual Investment Program was also prepared by NROs last year.

Three-Year Rolling Infrastructure Program (TRIP) 2018-2020

TRIP 2018-2020 was formulated and proposed for reinstitution to further synchronize and streamline infrastructure planning, programming, and budgeting processes in the government and ensure that respective agencies’ budget ceilings are allocated to priority infrastructure PAPs. It will aid in the monitoring and programming to attain the government’s commitment to increase public spending on infrastructure.

NEDA, through the InfraCom Secretariat, commenced processing of initial TRIP 2018-2020 submissions with the issuance of a call for submissions through the Public Investment Program Online (PIPOL) system in February 2017. TRIP submissions were consolidated and endorsed to the InfraCom-Technical Board (TB). The InfraCom-

TB approved the consolidated TRIP 2018-2020 in April 2017. Also in 2017, NEDA, through the InfraCom, also called for submissions for the next TRIP 2019-2021.

Shepherding the inclusion/ prioritization of programs and projects indicated in the long-term roadmaps/ICC Plans/NEDA Board approval

Program and Project Appraisal

In 2017, the NEDA Board approved 20 infrastructure projects in the amount of ₱985,389.86 billion. These projects were funded either locally or through ODA.

As core secretariat to the ICC, NEDA coordinated the conduct of 10 ICC-Technical Board (TB), six (6) ICC-Cabinet Committee (CabCom) meetings and two (2) joint ICC-TB and CabCom meetings wherein 64 items were discussed. Included in these agenda items were (a) 19 new projects; (b) 14 projects with request for loan validity extension/change in cost and/or scope; (c) two (2) projects for information; (d) four (4) projects for notation; (e) one (1) public-private partnership (PPP) project; (f) four (4) PPP projects for updates; (g) 17 projects for other matters/items; (j) two (2) projects for Joint INFRACOM and ICC matters; and (j) one (1) preliminary report under NEDA Secretariat appraisal.

NEDA also appraised and/or reviewed projects for ICC approval: one (1) project for local funding, eleven (11) projects for ODA financing, and three (3) for PPP. These were reviewed according to their financial, economic, technical, social, and environmental aspects and in terms of alignment and contribution to the PDP, as well as their compliance with existing laws, rules, and regulations.

NEDA also provided technical assistance to the ICC through the review of 10 infrastructure projects for ICC processing with incomplete documentary requirements. NEDA also evaluated requests for project restructuring (loan extensions, cost increases, and changes in scope, among others) and provided recommendations for ICC or DOF action.

400 Million-Peso Feasibility Studies (F/S) Fund

The F/S Fund, administered by NEDA, is used exclusively for the conduct of feasibility studies for non-PPP projects. It primarily aims to support proposed pre-investment activities of feasibility studies for government programs and projects. In 2017, 14 projects were funded, of which 12 were completed, while two (2) are ongoing. The total amount of awarded contracts is ₱350,843,329.15. Ongoing feasibility studies are for (a) the Mindanao Railway Project and (b) the Regional Fish Port Project for Greater Capital Region.

Value-engineering/ value analysis (VE/VA) studies under the NEDA-administered VE/VA Fund

To ensure that infrastructure projects are appropriately designed, VE/VA studies were undertaken by NEDA in 2017. The studies resulted in strategies that will optimize resources and investments in infrastructure.

A total of five (5) VE/VA studies were conducted for various selected infrastructure projects under the NEDA-administered VE-VA Fund. These were conducted to increase efficiency in infrastructure spending by helping minimize cost overruns, implementation delays, and changes in scope or work. From these projects, four (4) are ongoing while one (1) is undergoing procurement.

Enhancement of the PIP Online (PIPOL) System

NEDA spearheaded the development of the PIPOL System, an online database system for government projects, launched in 2016. In 2017, the agency continued to enhance the system to improve the government's investment programming and monitoring of priority programs and projects. The participation of government agencies and corporations in the use of the system facilitates the programming and budgeting process for programs and projects under the DBCC, InfraCom, ICC, and Congress.

The NROs also spearheaded the review of budget proposals and PAPs of RLAs, regional SUCs, and other government entities and submitted the validated/updated priority projects to the PIP, PIPOL System for inclusion in the 2018 agency budget proposals.

DEVELOPMENT PERFORMANCE MONITORING AND EVALUATION

NEDA provided useful monitoring and evaluation services to measure the development impact of programs and projects

Results Matrices (RMs)

To provide results orientation to the PDP, the RMs have been formulated and finalized through a consultative process that involved NEDA, the Philippine Statistics Authority, sector agencies, and research institutions. The RMs contain indicator statements and targets to be achieved for the next six years to track the gains achieved and serve as a tool in monitoring and evaluating the progress of the PDP and RDPs.

Socioeconomic Report (SER)

NEDA released the SER 2017 which featured an overview and evaluation of the government’s major groundworks laid down in 2017, including the recommended priority strategies for 2018-2019. To come up with the report, NEDA conducted various coordination and consultative meetings, and workshops with concerned government agencies and stakeholders.

Annual Regional Development Report (RDR)

RDRs were also prepared by the NROs, in parallel with the SER formulation. Similar to the SER, the RDRs serve as tool for the monitoring and evaluation of the implementation of programs and projects under the RDPs. They also assess the regions’ contributions to the national and international goals embodied in the 0-10 point Socioeconomic Agenda and the SDGs.

The NROs also issued regular regional economic situationers (RES) or socioeconomic reports on an annual and quarterly basis. Some include selected indicators such as monthly inflation rate, food and oil prices, quarterly employment rate and exports statistics, annual production statistics, and gross regional domestic product (GRDP). The RES reports also provide, among others, an assessment and economic outlook for each region.

Impact assessment studies for sharpening choice of policies and programs

Monitoring and Evaluation (M&E) Fund

The M&E Fund was included in NEDA’s 2017 budget to emphasize the government’s strong commitment to results and its continuing support for evidence-based policy making. The fund was intended to finance various M&E initiatives to measure development interventions successes and gain lessons from plan and program/project implementation.

Studies financed under the M&E Fund include the impact evaluation of the Light Rail Transit, Technical Education Skills and Development, Rural Road Network Development Projects, and National Shelter Program, among others.

Meanwhile, the United Nations Development Program (UNDP)-NEDA partnership agreement under the M&E Fund was signed in 2017 to pursue projects using Strategic Monitoring and Evaluation to Accelerate Implementation of the PDP 2017-2022 with the following components: (a) Management of NEDA M&E Fund; (b) Evaluation Capacity Assessment; (c) Advisory Services for the National Evaluation Policy Framework; and (d) Project Management.

Performance Review of Existing Mine Operations

NEDA facilitated the conduct of an objective, fact-finding, and science-based review of performance of existing mine operations pursuant to Resolution No. 6 of the Mining Industry Coordinating Council. This is to thoroughly assess the mining companies on the basis of their technical, legal, social, environmental, and economic credentials. The review aims to assist in identifying needed interventions to effectively address mining issues and concerns and recommend policy measures to further improve management and regulation of the mining sector.

Monitoring and evaluation of key government expenditures

Regional Project Monitoring and Evaluation System (RPMES)

The NROs prepared the RPMES reports, which are quarterly accounts of the implementation progress of government programs and projects at the regional level. They report on the overall performance and the financial and physical status of programs and projects undertaken by national government agencies,

LGUs, SUCs, and the provincial, city, and municipal government units. They also include expected results and immediate benefits or outcomes to be generated upon completion of programs and projects.

Field Monitoring Visit Reports

NEDA also conducted field visits to monitor and validate the status of the implementation of the programs and projects reported in the RPMES. Among the sites visited were in Bicol, Western Visayas, Eastern Visayas, Zamboanga Peninsula, MIMAROPA, Central Luzon, Davao, among others.

ODA Portfolio Review and Regular ODA M&E

Pursuant to RA 8182, NEDA submitted the 2016 ODA Portfolio Review Report to Congress in June 2017. NEDA conducted the review in consultation with implementing and oversight agencies, NROs, and development partners to address implementation bottlenecks including cost over-runs. The report helped improve the implementation of ODA-funded projects, facilitate resolution of key project implementation issues, and guided review findings of decision makers, among others.

Periodic assessments of the ODA portfolio performance reports were also prepared. These included reports on loans, grants, cost-overrun, alert mechanism, and technical assistance.

Project Facilitation

NEDA conducted monitoring and evaluation, as well as regular meetings at the national, regional, and sub-regional levels including four (4) Project Implementation Officers meetings and two (2) National Project Monitoring Committee meetings.

Joint Supervision Missions and Project Visits

Six (6) joint reviews and supervision missions and seven (7) project site visits were conducted by NEDA and its major development partners to assess the performance of various ODA projects such as (a) Second Cordillera Highland Agricultural Resource Management Project (CHARMP2); (b) Implementation Support Mission for the Learning, Equity, and Accountability Program Support (LEAPS); (c) Fisheries, Coastal Resources and Livelihood (FishCORAL) Project; (d) Special Program for Employment of Students (SPES) Impact Evaluation; (e) Convergence on Value Chain Enhancement for Rural Growth and Empowerment; and (f) *Kapit-Bisig Laban sa Kahirapan*-Comprehensive Integrated Delivery of Social Services (KALAHYI-CIDSS) Successor Plan Mission.

Project Facilitation, Monitoring, and Innovation (PFMI) Task Force

The NEDA Board approved the creation of the PFMI Task Force on June 27, 2017 to facilitate the development, approval, and implementation infrastructure flagship projects (IFPs) under the *Build, Build, Build* program. The Joint Memo Circular on the Implementation Guidelines for the Establishment of the PFMI Task Force was signed by NEDA, DOE, and Department of Budget and Management (DBM) on September 1, 2017.

Following this, a training workshop on Program Evaluation Review Technique - Critical Path Method (PERT-CPM) for Priority Programs and Projects was conducted for NEDA personnel and selected agencies.

Operationalization of the National Evaluation Policy Framework

NEDA has been fast-tracking the operationalization of the National Evaluation Policy Framework, a joint reform initiative between NEDA and the DBM for the purposive conduct of evaluations in the public sector in support of good governance, transparency, accountability and evidence-based decision making.

Information Technology-Business Process Management (IT-BPM) and Agribusiness

NEDA undertook studies on the IT-BPM and agribusiness that include the Governance Framework on the IT-BPM and agribusiness sectors. These seek to provide evidence and policy recommendations to aid in the choice of future policies and programs to help the sectors’ performance and contribute to employment generation and rapid and sustained economic growth.

ORGANIZATIONAL DEVELOPMENT

Organizational development was pursued to improve productivity and optimize strategic linkages to attain organizational effectiveness



NEDA developed the Strategic Human Resource Development Plan and conducted capacity-building programs for its personnel and officials to equip them and/or strengthen their skills, knowledge, and competencies in achieving the agency’s goals and providing better public service. A total of 940 personnel from NEDA offices and staffs attended various training workshops, broken down into the following number of trainings: 33 on leadership, 32 on technical trainings, 27 on administrative competencies, seven (7) on communication, and three (3) on gender and development. In addition, 14 trainings were conducted in-house and 86 were delivered by external service providers. The leadership trainings involved topics on coaching, mentoring, positive discipline, strategic decision making, industrial relations management, etc. The trainings on technical capacity-building included policy development and analysis, project monitoring and evaluation, statistics, program development, and investment appraisal, etc. Meanwhile, administrative competencies were also enhanced with topics on public sector productivity, procurement process, budget and performance tracking, records and information management, etc. Recognizing the importance of communication in policy-making, communication skills were also enhanced through effective technical writing and editing, presentation skills, branding, language proficiency, etc.

Project Development and Appraisal Team (PDAT)

In line with the agency’s continuing efforts to capacitate its personnel on project development appraisal, some NROs established the PDAT to (a) conduct trainings on preparation of project proposals; (b) prepare samples or templates of projects proposals; (c) advise project proponents on institutional implementation; and (d) advise on financing options for proposed projects.

Trainings were also conducted for NRO personnel to enhance their skills in undertaking project appraisal of proposals and feasibility studies.

Integrated and operational information system

Consistent with and supportive of NEDA’s business processes to facilitate information sharing between and among units and offices, the agency operated and maintained an integrated and operational NEDA-wide information system, including quality management assistance system that includes the following:

The Omnibus Office Memorandum on Strengthening the Internal Control System (ICS) of NEDA was issued in line with the need to strengthen NEDA’s management control system and ensure the institutionalization of adequate and effective ICS throughout the agency’s operating systems and support services operations.



The following office circulars were issued to improve NEDA’s systems and processes including productivity of personnel: (a) Amendment to the NEDA Full Flexi-time Policy and Policies and Guidelines on the Rendition and Payment of Overtime Services per Office Circular No. 07-2017; and (b) Amendment on the Revised Policy Guidelines and Procedures Governing Complaints and Grievances.

To ensure that all personal data and information collected are properly processed, the NEDA Data Privacy Guideline was finalized. The Disclosure Policy Guidelines of classified NEDA documents was also reviewed.

Information Technology (IT) solutions

NEDA procured various IT facilities that include software, hardware, tools, and supplies, to improve the organization’s workflow and processes, as well as increase productivity and efficiency between and among staffs and offices.

To ensure efficient and seamless communication between the NCO

and NROs, the communication system was enhanced through the implementation of Digital Telephony in all NEDA Offices. Some NROs also installed Government Network (GovNet), as provided by the Department of Information and Communications Technology for better internet connection resulting to more efficient and faster data transfers and government-to-government communications.

Upgrading, construction, and acquisition of physical assets

In 2017, a number of NROs were able to acquire land title, request for budget to construct buildings, and upgrade building facilities such as elevators and rainwater harvesting facility, among others.

ISO 9001-2015 certification of quality management system (QMS)

NEDA conducted a series of seminars, workshops, consultation, coaching, and capacity-building sessions to equip and guide the processors and implementing units in the full implementation, system review, and improvement process of the QMS. This is in continuation of the successful establishment and documentation of the ISO 9001:2015 Aligned QMS for the ICC Secretariat Appraisal and Facilitation of ICC Action Process at the NCO, which started in 2016.

To determine whether the objectives and requirements of the QMS were met and achieved, the Internal

Quality Audit (IQA) was conducted. The NEDA Quality Management Structure also conducted its first Management Review to evaluate the continuing adequacy, suitability, and effectiveness of the QMS and accordingly act and decide on issues for its improvement.

One full cycle of the implementation of the ISO 9001-2015 Aligned QMS for the ICC Process was completed. The Certificate of Conduct of IQA and the approved minutes of the 2017 Management Review were posted on the NEDA Transparency Seal.

At the regional level, several NROs have already been awarded with ISO Certification while others continued with their compliance with ISO 9001:2015 and QMS. The NROs also conducted trainings on (a) application for ISO Certification 9001-2015, (b) Risk-Based Thinking in ISO 9001-2015-Understanding,

and (c) Implementing Requirements, Effective Risk-Based Internal Quality Audit of a QMS, among others.

Staffing

NEDA prioritized the filling of vacant positions across units and offices. As of December 31, 2017, a total of 1,144 out of 1,295 positions have been filled, equivalent to 88 percent of total number of positions. Of these, 501 out of 603 (83%) were from the NCO while 643 out of 692 (93%) were from the NROs.

NEDA Bids and Awards Committee (NBAC)

The NROs also reconstituted and designated the NBAC members, technical working group, secretariat, and observers in compliance with the provisions of the Government Procurement Reform Act (RA 9184). Special orders were issued on amendments on the duties and responsibilities of each sub-committee members.



STRATEGIC LINKAGES

Results-Based Monitoring and Evaluation System (RBME) linked to socioeconomic statistical systems and institutional framework

To enhance the public sector's performance monitoring and accountability, the RBME System was strengthened through seminars on RBME for RLAs, LGUs, and RDC public sector representatives, among others. These discussed the RBME policy framework and development context, methodological foundations, and analytical tools including planning for results and evaluating performance.

Linkages with Stakeholders

NEDA continued to build strong partnerships with different stakeholders, recognizing the importance of building strong partnerships with multi-stakeholders in facilitating programming, project implementation, monitoring and evaluation, and development research to achieve inclusive growth through collaboration.

Strategic linkages were forged with regional, and local partners, agencies and institutions through:

Regional Gender and Development Committee (RGADC)

NEDA provided inputs on various resolutions of agencies to enjoin data sources to produce and support the RGADC and promote and coordinate the generation of sex-disaggregated data (SDD) for policy formulation, development planning, and project monitoring purposes.

To capacitate data sources in establishing, collecting, using, and managing SDD, the RGADC also included SDD activities in its work program. Meanwhile, studies were also conducted by NROs to identify the gaps in gender statistics and address SDD requirements embodied in the RDPs.

Good Practice Award (GPA)

NEDA validated 12 entries in the 2017 GPA, including projects on health, irrigation, and environment, among others, a knowledge management initiative of NEDA. The GPA is a biennial search for outstanding implementing agencies that demonstrate best practices in achieving desired outcomes and in resolving recurrent issues during the program and project implementation.

Philippine Tariff Finder (PTF)

NEDA, through the Tariff Commission, updated the PTF which serves as a repository of pertinent tariff-related information. It also includes an e-manual on tariff classification and briefers on the tariff Nomenclature and Free Trade Areas.

COMMUNICATION AND STAKEHOLDER ENGAGEMENT

NEDA recognizes the important role of communication and advocacy in rallying support for and ensuring sustainability of its programs and initiatives.

Hence, continuous and improved communication and stakeholder engagement activities were implemented and spearheaded by the Development Information Staff (DIS) on socioeconomic issues to create better public understanding and gain support in achieving inclusive growth and working towards the fulfillment of the country's long-term vision or *AmBisyon Natin 2040*.

Guided by NEDA's Communication and Stakeholder Framework, NEDA intensified its communication efforts through the conduct of communication and stakeholder activities including social and mass media (e.g., infographics, videos, media and press releases, briefings, conferences, events, etc.) to raise awareness on current economic issues, government policies and projects, and other important socioeconomic development initiatives (e.g. tax reforms, infrastructure projects, rice tariffication, labor and employment, macroeconomic figures, etc.). It also continued to disseminate relevant publications and information, education, and communication (IEC) materials to its stakeholders that include government officials, NGOs, CSOs, media, academe, and the general public.

In our journey to a *matatag, maginhawa, at panatag na buhay para sa lahat* by 2040, it is critical that the PDP 2017-2022 gets widespread multistakeholder support to ensure that succeeding administrations will build on its gains. Hence, NEDA implemented communication campaigns for

both the *AmBisyon Natin* 2040 and the PDP through various events, activities, and (IEC) materials. These campaigns commenced through the launching of the PDP in June 2017 which was witnessed by more than a thousand stakeholders from the government, private sector, academe, civil society organizations, media, and development partners. The event also featured booths that showcased various government programs, activities, and projects.

Nationwide events were also conducted in the form of roadshows, expos, summits, forums, and presentations. Major and ride-on events of partner agencies and organizations have reached at least 45,000 individuals from the national and local governments, academe, youth and students, non-government and civil society organizations, private sector, development partners, and media.

PDP and Regional Development Plans (RDPs) Regional Roadshows

The PDP launch also signaled the start of campaigns for the RDPs, as spearheaded by the NROs. From July to August 2017, the 15 NROs conducted regional roadshows with the theme “Tayo na, abutin ang *AmBisyon Natin*” that launched the PDP together with their respective RDPs across the country.

NEDA’s campaigns were also present in numerous regional and national radio and television channels. The NEDA Development Information

Staff (DIS) also developed various online communication materials on the PDP and *AmBisyon Natin 2040*. Some of which include the *AmBisyon Natin 2040* Facebook page (with 104,460 likes and engaged almost 1,000,000 Facebook users as of end of 2017); video materials on PDP and AmBisyon NEDA’s YouTube channel (with 305,762 total views); and NEDA’s website pages dedicated for PDP and AmBisyon (with 69,000 sessions for the same period). These numbers indicate high engagement and reach of online communication materials.

Building Partnerships

To widen the reach of its communication efforts, NEDA developed new multistakeholder partnerships while strengthening previously established ones. These partnerships allowed for deeper discussions and communication to institutionalize the PDP and *AmBisyon Natin 2040* in other sectors outside the government. In fact, many of these agencies and organizations have aligned their plans with the goals of the PDP and AmBisyon and have since actively and continuously collaborated with NEDA in various activities.



The Philippine Federation of State Universities and Colleges Student Leaders pledged their support to the PDP and AmBisyon Natin 2040 during the **National Student Regents' Summit 2017**. The organization's statement of commitment, accompanied by action plans will be implemented in their respective universities or colleges and communities.



NEDA partnered with the De La Salle University School of Economics Student Government in conducting the **AmBisyon 2017 Case Competition** in June 2017.

NEDA hosted the opening ceremony of the **28th National Statistics Month** on October 2, 2017 with the theme “Facts and Figures for the Future: Statistics for Evidence-Based Decisions towards AmBisyon Natin 2040” in partnership with the Philippine Statistics Authority (PSA).

Internal capacity-building activities were also implemented for employees to become better advocates for PDP and *AmBisyon Natin 2040*. The whole NEDA community, including its attached agencies were involved in these advocacy campaigns – either as main organizers, partners, and resource persons.

The Communication and Advocacy Committee was also established, among others, to implement communication strategies to address NEDA's priority issues and concerns, starting with the PDP and *AmBisyon Natin 2040*.



Dr. Clarissa C. David of the University of the Philippines College of Mass Communication served as one of the resource speakers during NEDA's Speakers' Bureau and Media Training to equip speakers and presenters on how to communicate PDP and AmBisyon. She was also the study team leader for the focused group discussions that aimed to determine the aspirations of Filipinos, particularly the poor and marginalized, for self and for the country.



Members of NEDA's Communication and Advocacy Committee, chaired by Undersecretary Jose Miguel Dela Rosa and is composed of representatives from both NCO and NROs, convene in November 2017 to assess the PDP/Regional Development Plan Roadshows held from June to August of the same year.



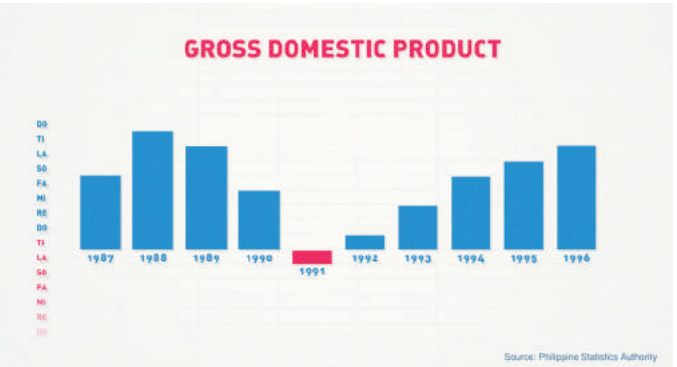
Tunog ng Progreso: An Anthem of Progress

NEDA also explored alternative methods to maximize its efforts in promoting *AmBisyon Natin 2040* and PDP 2017-2022. Thus, in September 2017, the DIS collaborated with creatives agency Dentsu Jayme Syfu to come up with a creative interpretation of the country's economic performance in recent years. The song entitled "*Tunog ng Progreso*," was created to promote better

understanding and appreciation of the amount of progress that the nation has achieved, with the intention to inspire everyone to unite for a better future.

Because of its innovative and creative execution, the song was featured in various print and online media. By the end of 2017, "*Tunog ng Progreso*" won the Silver Awards for Best in Creative Use of Data and Best in Audio Craft (Radio and Digital) at the

prestigious Kidlat Awards, an annual creative competition that celebrates and recognizes the country's best advertising work. The NEDA-DIS also started the production of the "*Tunog ng Progreso*" dance video featuring officials and personnel from the NCO and NROs, as well as sceneries across the country, in preparation for NEDA's 45th Anniversary celebration in 2018.



ATTACHED AGENCIES

Apart from coordinating development initiatives to achieve inclusive growth across the entire government body, NEDA's six (6) attached agencies specializing in statistics, research, public-private partnerships, and tariff matters complemented NEDA's work.

Philippine Statistics Authority (PSA)

PSA, as the government's primary statistical agency, provided timely and accurate statistics which served as valuable inputs in the formulation of national development plans and programs, in the conduct of research, and in making vital business decisions of both the government and the private sectors.

In 2017 alone, the PSA disseminated 709 statistical products, including 476 publications in data files/electronic publications or book format. It also reached its 100 percent target in disseminating statistical products within the prescribed period or Advance Release Calendar. Moreover, the PSA disseminated and monitored 14 statistical resolutions and updated five (5) statistical classification systems.

As the central repository of documents on the civil status of individuals, a total of 19,595,430 applications for birth, death, marriage and certificates of no marriage and petitions decided were processed and released by the PSA through Helpline plus, e-Census, Census Serbilis Centers and other channels. This is higher than the 14,832,140 target for 2017 or an accomplishment rate of 132.1 percent. It also posted 98 percent in terms of the percentage of request for civil registry documents granted within the prescribed schedule.

Philippine Institute for Development Studies (PIDS)

As the Philippine government's primary socioeconomic think tank, PIDS completed several research studies on agriculture, fisheries and forestry, fiscal policy and budget management competition, trade and industry, disaster risk reduction and management, gender and development, health policy, infrastructure, transportation and communication, policy innovation, research and development, including the improvement and development of policy tools and statistics, among others. It also conducted monitoring and evaluation studies, as well as workshops to improve the conduct of these studies.

Philippine National Volunteer Services Coordinating Agency (PNVSCA)

The PNVSCA continued to take the lead in advocating volunteerism for nation-building and international cooperation. It facilitated and monitored the deployment of 549 local and foreign volunteers in development programs and projects in the country and assisted 270 local partner institutions, particularly in areas with high poverty incidence. The Agency also spearheaded the conduct of the annual Search for Outstanding Volunteers in 2017.

Philippine Statistical Research and Training Institute (PSRTI)

During the year, the PSRTI completed 12 research projects that were either published or presented in a recognized conference/convention or adopted for practical application. Moreover, it provided more than a thousand training hours to 969 personnel in the 46 (regular and customized) training courses it conducted on basic to advanced statistics, monitoring and evaluation, and national accounts.

To ensure utilization of research outputs, 100 percent of PSRTI's completed researches for the past three (3) years were published in a recognized journal or adopted for practical applications. All research projects in 2017 were also completed according to schedule.



Tariff Commission (TC)

As the principal and independent authority on tariff and trade remedy measures, the Tariff Commission prepared the following EOs signed by the President: (a) EO 20, s. 2017 prescribing the 2017-2020 most favored nation (MFN) tariff schedule of the Philippines; (b) EO 22 extending by one year, the duty-free incentive on importation of capital equipment, spare parts, and accessories by enterprises registered with the Board of Investments; (c) EO 21 implementing tariff commitments under the World Trade Organization

(WTO)–Information Technology Agreement; and (d) EO 23 extending the effectivity of the MFN tariffs on certain agricultural products and implementing other Philippine commitments under the WTO Decision on Waiver Relating to Special Treatment for Rice of the Philippines. The Commission also issued 541 tariff classification rulings to provide trade assistance and facilitate domestic industries.

Public-Private Partnership (PPP) Center

The PPP Center drafted the following PPP Governing Board-

approved Policy Circulars to implement best practices and streamline the PPP processes in the country: (a) Policy Circular on Appointment of Priority Advisors for PPP Procurement; (b) Policy Circular on Managing Unsolicited Proposals; and (c) Policy Circular on Bid Parameters.

It also provided inputs to policy instruments related to the implementation of PPP projects as well as conducted events to increase awareness and provide a wider understanding on PPP services.
